Cookie policy

1. Introduction

This Website https://maitredanoisclara.com (hereinafter the "Website") is operated and maintained by Maitre DANOIS Clara, independant lawyer from the law firm Infuero, registered with the Luxembourg Bar, 21 rue Glésener, 1631 Luxembourg Gare, Luxembourg, B264370, as data controller (hereinafter: "we", "us", "our").

The Website uses cookies and other related technologies (all technologies are referred hereto as "Cookies"). The purpose of this document is to inform you about the information we collect as a result of our use of Cookies, how we processed it, why we do so and when we share it with third parties. The data subject concerned are the users of this Website (hereinafter: "you", "your", "yours").

2. What are cookies?

Cookies are small data files that are sent along with pages of this Website and stored by your browser on the hard drive of your computer or another device you use to navigate on our Website. The information stored therein may be returned to our servers of the relevant third parties during a subsequent visit. Some cookies are only stored for the period during which your internet browser remains active and others for a longer predetermined period.

W explain below how you can delete, block or disable Cookies though your internet browser settings, but we inform you that some or all of the features of our Website and the services we offer may not work properly.

3. What are scripts?

A script is a pice of program code that is used to make our Website function properly and interactively. This code is executed on our server or on your device.

4. What is a web beacon?

A web beacon (or a pixel tag) is a small, invisible piece of text or image on a website that is used to monitor traffic on a website. In order to do this, various data about you is stored using web beacons.

5. Why do we use cookies?

We use Cookies to store information about your browsing on our Website, which helps us to improve your browsing experience and our communication with you. Some Cookies are important for the proper functioning of our Website and services.

Cookies allow us to collect information for different purposes. For example, we collect information about the type of device you use, its operating system and the internet browser you use so that we can adapt our content to display it correctly. We collect information to remember your preferences and communications with us. We also collect information to improve our communication with you, such as how you access our Website, the pages you visit and the links you click.

6. What type of Cookies do we use?

6.1 Statistic Cookies/performance Cookies

Statistic cookies help us understand how visitors interact with our Website by collecting and reporting information anonymously. This include cookies from third-party analytics services.

6.2 Social media buttons

On our Website we have included buttons for LinkedIn. These button work using pieces of code coming from LinkedIn itself. This code places Cookies. These social media buttons also can store and process certain information, so a personalized advertisement can be shown to you.

- Links consulted on the Website.

You can disable the use of Cookies via your browser, but please note that our Website may no longer work properly.

10. Conservation periods of your personal data
